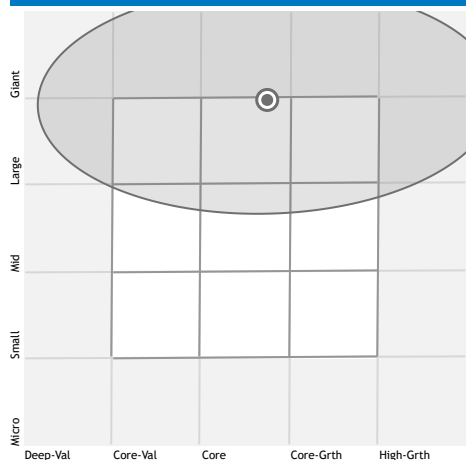

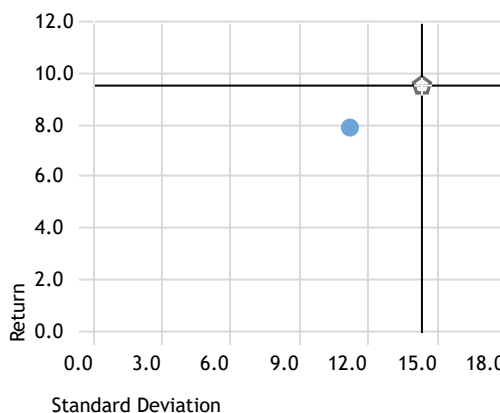
## Actively Managed Multi-Capital Growth Portfolio

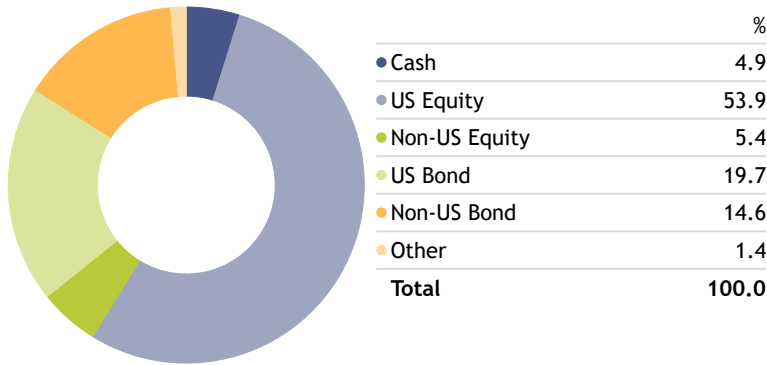

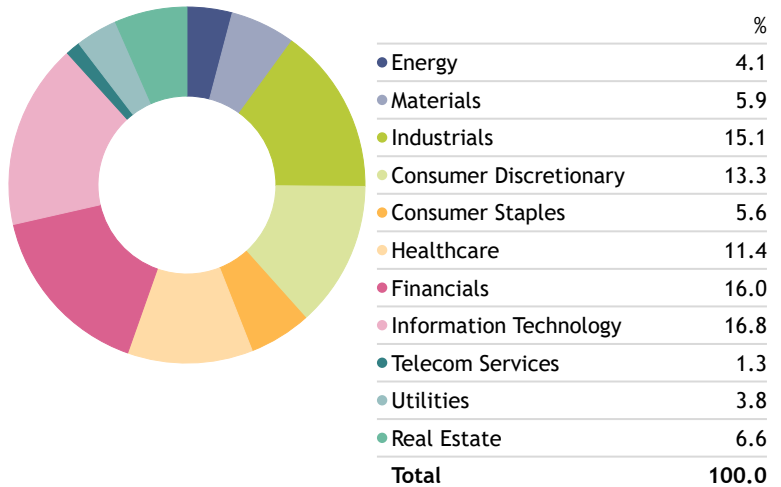
## Asset Allocation

Portfolio Date: 4/30/2017



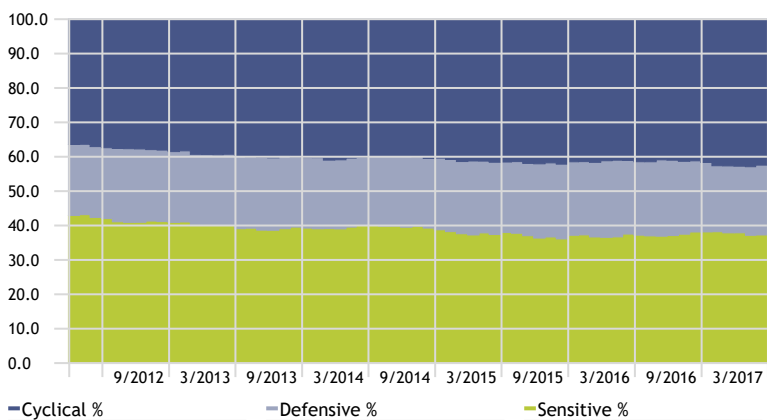
## GICS Equity Sectors

Portfolio Date: 4/30/2017



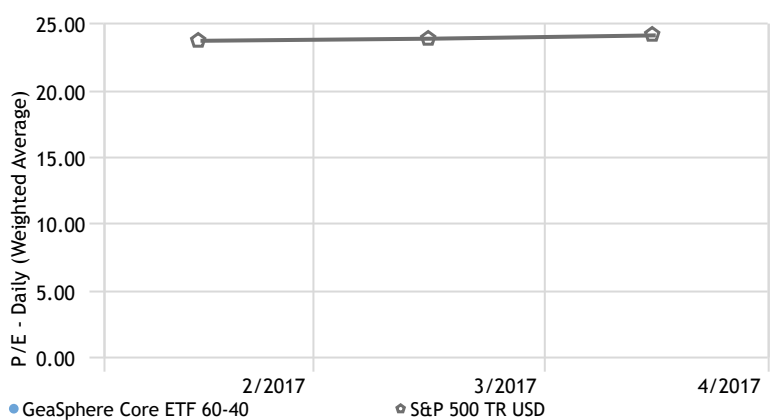
## Equity Super Sectors
